In preparation for this year's Conference and Review, these pearls of wisdom written 10 years ago challenged us, as FANNP members, to also prepare for the conference mentally; these points remain valid today. The following was written by an integral member of FANNP, Pamela (Penelope) Laferriere:

How might you best prepare to get the most from your symposium experience? Here are some suggestions:

**Plan to attend**. Register for the event. Go to www.fannp. org and download a brochure. Consider the benefits of becoming a member of FANNP. Book your hotel reservation.

**Review the brochure**. Consider attending sessions from both Track A and Track B, the update and review tracks respectively. Mull over the session topics and descriptions. Also, consider attending the other activities that offer unique networking opportunities for new and experienced NNPs.

#### Florida Association of Nurse Practitioners (FLANP) Policy Statement and Platform

health care through removal of legislative barriers that prevent delivery of care by APNs. FLANP seeks to foster and support respect among all nurses. FLANP will only pursue policies which are in the public interest, and which promote access to affordable quality health care for all Floridians. It is the policy of FLANP to educate the public on health issues and the advanced practice of nursing in order to promote health and contain costs. FLANP seeks to work collaboratively with other corporate, governmental, non-governmental, and professional organizations toward the accomplishment of our mission.

#### Platform:

- 1. Full prescriptive authority with DEA credentialing for Advanced Practice Registered Nurses (APRNs).
- 2. Designate Florida APRNs as severally culpable autonomous licensed independent health professionals.
- 3. Change the legal professional name for NPs, CNMs, CRNAs, and CNSs to APRNs (consistent with the national standard). [As per NCSBN consensus model].
- 4. Authorize APRNs to sign involuntary petitions for commitment (Baker Act –BA-52) forms.
- 5. Authorize APRNs to determine Maximum Medical Improvement (MMI) and Permanent Impairment Rating (PIR) for Workers' Compensation claims. Authorize APRNs to prescribe home health care.
- 6. Authorize APRNs to prescribe physical/occupational therapy.
- 7. Empanelment of APRNs to all third party payers (all public and private entities) for full scope of practice services.
- 8. Authorize APRNs to be Primary Care Providers (PCPs) under all third party payer plans.
- 9. Authorize APRNs to sign death certificates.
- 10. Authorize APRNs to sign fetal demise and birth certificates.
- 11. Authorize APRNs to order all diagnostic and laboratory tests.
- 12. Define APRNs as Licensed Health Professionals to sign all designated health forms.
- 13. Designate APRNs as Medicaid PCPs.
- 14. Specifically designate APRNs to autonomously and independently act as directors for Florida Health Care Homes (AKA Medical Homes).
- 15. Place all control of Florida APRNs, RNs, and LPNs solely under the auspices and control of the Florida Board of Nursing. Remove all aspects of professional nursing practice regulation from any other authority agency of government. [As per NCSBN consensus model].
- 16. Change third party payer (insurance company) reimbursement to "any willing provider" status.
- 17. Adopt the National Council of State Boards of Nursing consensus model for APRN regulation.

### Nurse Practitioners: Part of the Solution to the Primary Care Physician Shortage

Florida has a primary care physician shortage. Less than half of Florida physicians accept Medicaid. Half of Florida physicians will reach retirement age over the next ten years.

- An estimated 3 million Floridians have now gained insurance coverage under the Patient Protection and Affordable Care Act.
- Another 1 million Floridians are in the coverage gap and are potentially eligible for insurance, if they can afford the costs. They too need primary care.
- When people do not have primary care access they go to emergency rooms for care, driving up tax payer costs.

## Florida needs a cost effective, free market, creative solution to meet these needs.

- Removing restrictive Nurse Practitioner licensure laws, has been demonstrated in other states to increase primary care access and reduce costs.
- Less restrictive licensing also has shown an added benefit of attracting more Nurse Practitioners into a state, thus improving economic activity.
- Almost half the states have stopped the practice of restricting NP licensure.

#### In order for Florida to fully take advantage of all the training and skills of Nurse Practitioners, certain legislation must be modernized.

- Removal of physician supervisory licensure requirements on Nurse Practitioners
- Required empanelment of Nurse Practitioners by all Medicaid HMOs and insurance companies
- · Ability to sign a Baker Act
- Ability to sign death certificates
- Ability to certify DNR orders
- Ability to sign all needed documents for patient care (global signature)
- Review of and amend additional laws as appropriate

Research by the Institutes of Medicine and hundreds of other reputable studies have shown that Nurse Practitioners who practice without restrictive licenses deliver safe, cost effective, high quality care, with equivalent outcomes to physicians.

Florida has an opportunity to embrace an economically viable, free market solution to the primary care access problem, while at the same time improving the economic activity of the state.

The costs to Florida tax payers are nothing, while these changes could potentially save the state billions of dollars per year.



Terri Marin, PhD, NNP-BC, FAANP was awarded a grant from the American Association of Nurse Practitioners as the PI for her study titled "Examining Patterns of Renal Sodium Handling and Effects of Sodium Supplementation among Premature Infants". Dr. Marin will collaborate with Cynthia Mundy, DNP, NNP-BC, Christy Cockfield, DNP, NNP-BC, Amy Gates, RD, and Jatinder Bhatia, MD at CHOG Neonatal Intensive Care Unit to examine somatic growth trends in premature infants ≤ 30 weeks' gestation before and after the

implementation of sodium supplementation guidelines administered for late-onset hyponatremia.


Additionally, Dr. Terri Marin et al. published their manuscript titled, "Does Red Blood Cell Irradiation and/ or Anemia Trigger Intestinal Injury in Premature Infants with Birth Weight ≤ 1250 grams? An Observational Birth Cohort Study" in BMC Pediatrics and "Statistical methods for characterizing transfusion-related changes in regional oxygenation using Near-infrared spectroscopy (NIRS) in preterm infants" in Statistical Methods in Medical Research. Congratulations Dr. Marin and team!

## **Designing a Poster for Presentation**



### **Example of poster for presentation**

- 1. Lead investigator- name of lead investigator and any secondary investigators.
- 2. Logo or graphics of the organization that has supported your work.
- 3. Executive summary- brief description of project, including medical arena project will benefit.
- 4. Review of the literature- how does the literature support your research?
- 5. Methods-type of research methods you followed to summarize your data.
- 6. Visual graphics of research data, including charts, graphs, or pictures of project work.
- 7. Summary of data collection- Key points of data collection results.
- 8. Dissemination-Transfer of research-based knowledge into routine clinical practice.
- 9. Conclusion- Restate the focus of your research and summarize main points of evidence.
- 10. Acknowledgements- Include any person, institution, or organization that assisted with the project.

Most of all, make it your own....be creative!

## Scholarships will be Awarded at the 2018 FANNP Annual Conference

FANNP as an organization is committed to educational advancement and is proud to be able to award scholarships to nurses and NNPs continuing their educational pursuits in the field of neonatal health care.

At the end of the year a percentage of the money in the FANNP general operating budget is placed in a scholarship fund.

Scholarships are awarded annually at the FANNP Symposium. The scholarship recipients give back and provide a short article, case study, practice pointer, evidenced-based practice update or literature review which is published in the FANNP Newsletter for all of us to read.

All FANNP members pursuing a degree in neonatal health care are encouraged to apply. Scholarship monies can be used for tuition, books or any expenses incurred while in school.

If you are interested in applying for a 2019 scholarship, please see the eligibility guidelines and contact <u>scholarships@fannp.org</u> for an application.

## 2019 Scholarship Eligibility Guidelines

- 1. Applicants must be FANNP members.
  - a. All voting members, student members and associate members are eligible.
  - b. Priority for scholarship awards will be given to voting members, followed by student members and then associate members.
  - c. Priority for scholarship awards will be based on length of membership and service to FANNP.
- Applicants must be a licensed RN, ARNP, NNP or equivalent.
  - a. Preference will be given to currently licensed NNPs working towards an advanced NNP degree.
- 3. Applicants must attend an educational program leading to a degree related to the health care field during the application period.
  - a. The application period for the 2019 scholarship is September 15, 2018 to September 15, 2019 (i.e. to be eligible for a 2019 scholarship you must have attended classes sometime between September 15, 2018 and September 15, 2019).
  - b. An applicant may receive a maximum of two scholarship awards for each degree sought.
- 4. Applicants will provide a short article, case study, practice pointer, evidenced-based practice update or literature review to be published in the FANNP Newsletter.

To obtain a scholarship application email <u>scholarships@</u> <u>fannp.org</u>. Completed applications must be postmarked by September 15 each year.

## Calling for Research Proposals... FANNP Grants Available

Each year FANNP sets aside funds for the support of research projects. Applications for funding are reviewed by the Research Committee. The Research Committee makes recommendations to the Board of Directors on proposals received. Members of the Research Committee are appointed by the Board of Directors. The grant application period is rolling—there is no deadline for grant submission. Grants will be awarded within six weeks following submission, based on the Research committee and BOD decision.

- 1. B- Infants with hyperthyroidism may present with growth restriction, tachycardia, arrhythmias, hypertension, tachypnea, poor feeding, vomiting, hyperthermia, tremors, hyperalertness, and irritability.
- 2. A- Duodenal atresia/stenosis, esophageal atresia, imperforate anus, fistulas, and webs are GI findings commonly associated with Trisomy 21.
- 3. C-Treatment of alloimmune thrombocytopenia includes transfusion with maternal platelets that have been washed and suspended in AB negative plasma. Serial transfusions may be necessary.


