For 2020, the FANNP Board of Directors is excited to announce the scholarship award amounts have been increased and will range from \$1000 to \$2000. Award amounts are based upon the application criteria and quality of

newsletter submission.

Scholarship monies can be used for tuition, books or any expenses incurred while in school.

All FANNP members pursuing a degree in neonatal health care are encouraged to apply for a scholarship. Or, do you know an NNP student? Encourage them to become a FANNP member and apply for a scholarship.

### Scholarship Application 2020 Eligibility Guidelines

- 1. Applicants must be FANNP members.
  - a. All voting members, student members and associate members are eligible.b. Priority for scholarship awards is given to voting members, followed by student members and then associate members.
  - c. Priority for scholarship awards is based on length of membership and service to FANNP.
- 2. Applicants must be a licensed RN, ARNP, NNP or equivalent.
  - a. Preference will be given to currently licensed NNPs working towards an advanced NNP degree.

3. Applicants must attend an educational program leading to a degree related to the health care field during the application period.

- a. The application period for the 2020 scholarship is September 15, 2019 to September 15, 2020 (i.e. to be eligible for a 2020 scholarship you must have attended classes sometime between September 15, 2019 and September 15, 2020).
- b. An applicant may receive a maximum of two scholarship awards for each degree sought.

4. Applicants will provide a short article, case study, practice pointer, evidencedbased practice update or literature review to be published in the FANNP Newsletter.

### **Unprecedented Times: NRP, BLS and PALS**

I am sure everyone is tired of hearing about COVID-19 so I am not going to talk about it directly. I am going to address some work-related requirements that have been affected by COVID-19. If you had BLS, NRP, or PALS due for renewal this Spring, you are more than likely expired and wondering about renewal. You may be thinking, "What are my responsibilities?"

The American Heart Association (AHA) issued a couple of updates with the last one on March 31, 2020. This update supersedes the previous one on March 13, 2020. Essentially, the AHA is extending AHA Instructor and Provider Course Completion Cards for 120 days beyond their recommended renewal date, for cards that expire beginning in March 2020. Of note, this references cards that are still valid in March 2020. For providers, whose cards have expired, the AHA will allow instructors to provide remediation during update courses. The timeframe for this is over the next 120 days. The responsibility for the management of the extension and record keeping will be with the training centers.

American Academy of Pediatrics (AAP) Life Support posted a couple of recommendations, one in March and another in April. The latest recommends for individuals whose NRP expires in March, April, May, June, or July 2020, have an extension for up to 120 days. They do leave the decision for the extensions to the discretion of the employers and regulatory bodies who require current NRP cards. To the individuals who are required to have NRP cards, it is your responsibility to find out what your institution's policy will be.

My hospital sent out an update outlining what the extensions will be for BLS, PALS, and NRP. They do state that if an employee goes to other hospitals, the employees are responsible for knowing what the other hospitals are requiring as the AHA and the AAP are leaving extensions up to the individual facilities to determine. Also, bear in mind there could be more recommendations based on how the COVID-19 pandemic evolves.

Personal note: Congratulations to all graduates! After working so hard, the ending must seem anti-climatic but just remember this is not an ending but a new chapter in the book of your professional life!

#### Spring 2020, Covid-19 Pandemic

All that we have known has been shaken to its core. As we celebrated ringing in 2020, who would have thought that just three short months later we would all be quarantined in our homes, wearing masks everywhere, and social distancing? As of June 20, 2020, who would have thought that we would lose approximately 121,000 Americans. This has truly been surreal.

Healthcare workers have surely taken the brunt, especially in places like New York, New Jersey, Massachusetts, Michigan and Illinois where the bulk of the cases of Covid-19 have been the highest. In Florida, at the time of writing, there have been 46, 944 cases and 2052 deaths. How are healthcare providers going to cope with what they have seen? These experiences will surely take its toll. Nationally and globally, there has been such an outpouring of support for healthcare providers and the role we play caring for patients every day. Some of my colleagues

have felt guilty because those of us in the NICU have been tucked away and are not experiencing what those who work in the adult ICUs are experiencing. But there is

beaches are beginning to open in some areas. Under Phase 1 rules, restaurants and beauty salons are opening. We still must protect ourselves and those who are most vulnerable by wearing our masks, washing our hands, and social distancing. We will all get through this together as a community of healthcare providers who are dedicated to our patients and families.

- Cough
- Shortness of breath or difficulty breathing
- Fever
- Chills
- Muscle pain
- Sore throat
- New loss of taste or smell

Look for emergency warning signs for COVID-19. If someone is showing any of these signs, seek emergency medical care immediately:

- Trouble breathing
- Persistent pain or pressure in the chest
- New confusion
- Inability to wake or stay awake
- Bluish lips or face

Call your medical provider for any other symptoms that are severe or concerning to you.

announced during the annual FNPN conference. Recipients will be notified approximately three (3) weeks before the annual conference. The deadline for submitting an application is July 15, 2020 at 5:00PM Eastern Time.

At the virtual meeting in April of the Florida Coalition of Advanced Practice Nurses, many representatives and lobbyists were represented. Strategies to develop and support legislation for expanding services to those affected by COVID-19 were discussed, with emphasis placed on mental health services. Efforts to implement HB 607 have been sidelined by the COVID-19 pandemic. At the June 5th FL BON Meeting, long term planning for implementation will be discussed. The next meeting will be held in July.

#### Important Message regarding HB 607 from the Board of Nursing:

- The new law takes effect on 7/1/2020.
- APRNs WILL NOT automatically assume autonomous practice on 7/1/2020. There will be a registration application to

complete and submit to the Board of Nursing for approval.

- The Board staff cannot predetermine eligibility for the autonomous practice registration requirements.
- Additional information will be posted on the Board's website once the Board has confirmed an implementation plan for the new law following its June 5th meeting.

In addition, the Florida Board of Nursing has extended the license renewal period for RN's & APRN's due 7/31/2020 to 8/31/2020. Now is a great time to take advantage of the availability of FNPN's online mandatory compliant Controlled Substance Course for licensure renewal!

Other states are also extending licensure deadlines, so check with your State's BON.

FANNP would also like to congratulate FANNP Member, Melissa Dunham, a 2nd year PhD Student at Augusta University, for acceptance of her first manuscript for publication! Melissa's publication (co-authored by Dr. Terri Marin), "NICU Maternal-Infant Bonding: Virtual Visitation as a Bonding Enhancement Tool" is presented in the Journal of Perinatal and Neonatal Nursing; her abstract follows.

The admission of an infant to the neonatal intensive care unit (NICU) presents specialized barriers to the maternal-infant bonding (MIB) process. Virtual visitation (VV) provides a mother with the opportunity to have continual access to her hospitalized infant via a one-way live Web camera. While increasingly used in the NICU, VV remains a novel concept. The objective of this study was to introduce a conceptual model that incorporates the use of VV into the NICU MIB process. Adapted from the Model of Mother-Infant Bonding After Antenatal HIV Diagnosis, a newly developed model of MIB using VV as a bonding enhancement tool is offered. A Model of NICU Maternal-Infant Bonding Incorporating Virtual Visitation presents the NICU bonding process in a chronological manner, with 5 primary propositions and an explanation of their related themes. Virtual visitation is introduced into the bonding process and is shown to act as a moderated variable. A Model of NICU Maternal-Infant Bonding Incorporating Virtual Visitation introduces VV as a tool to enhance the MIB process that occurs in the NICU. The model provides the basis for the development of a research program to examine the multiple potential effects of VV in the NICU.

In addition to her current status as PhD Student, Melissa is also Director of NNPs at Prisma Health Children's Hospital, Greenville, SC. Congratulations Melissa!

The Research Committee invites submissions by members and non-members. Participation is open to health professionals whose specialty has a focus on the Neonatal Population (this includes but is not limited to NNPs, RNs, Clinical Nurse Specialists, & Neonatologists). We invite colleagues to share their expertise in one of the following categories:

- Original Research
- Innovations in Practice or Education
- Patient Safety
- Quality Improvement and Benchmarking Initiatives
- Case Studies

Please note that a Literature Review on a specific topic will not be accepted for poster presentation.

#### POSTER PRESENTATION

All abstracts will be considered for poster presentation. Detailed instructions for the poster presentation will be provided to the Primary Author at the time of abstract acceptance.

#### SUBMISSION REQUIREMENTS

Abstracts must be submitted electronically in Word Format (no PDFs). Abstracts should be no longer than 500 words, single-spaced, 12-point font, with up to 2 additional bibliography pages. The content should be presented in the form of a structured abstract with format appropriate to category. For example...

Research:

- Purpose
- Background/Significance

- Methods
- Results
- Conclusions
- Discussion
- Major References

Case Study: (Please do not include any identifiable information)

- Introduction
- Case Presentation:
  - History of Present Illness
  - Hospital Course
  - Family History (if indicated)
  - Social History (if indicated)
  - Labs, Images, Studies
- Discussion

A signed conflict of interest statement & CV of primary author (required for CE credits) must be submitted with the abstract. Abstracts that do not follow the submission guidelines will not be reviewed. Abstracts previously presented in other arenas are eligible for submission. FANNP would like to publish accepted abstracts in our Newsletter during the year. You will be asked to give your permission when applying.

- Care Packages are designed to meet the needs of parents of preemies at every stage of the prematurity journey. They are involved from the early days in the NICU to the transition home. Three varieties of Care Packages are available:
  - o NICU -- for parents during their journey in the neonatal intensive care unit
  - o Transition Home -- provides information and resources to help ease the overwhelming feelings that can accompany bringing their baby home
  - o Remembrance -- provides useful information for the healing process and a memento to honor their baby
- MyPreemie app promotes parent well-being and engagement while in the NICU and after transitioning home. Features include a built-in pocket guide, journaling, and a development tracker to help parents stay informed and organized. It's available for Android or iPhone in both Spanish and English.
- Preemie Parent Mentor Program\* provides resources and peer support to parents during their time in the NICU, transitioning home, or if they've experienced a loss. Parents are matched with a mentor that has had a similar prematurity journey. Mentors are available by phone, video chat, text, or email.



Graham's Foundation recently introduced a new capability within their mentor program. Called "Connect," it enables preemie parents to connect in real time with one of the organization's trained mentors. Using a telehealth-style platform, parents can select a mentor and schedule an appointment to speak with them.

1. C- Group B strep is a gram-positive catalase negative organism that appears as cocci in pairs and chains on gram stain. Respiratory distress is a common finding in GBS positive neonates, but may also exhibit acrocyanosis, and hypoglycemia.

2. A- Cryoprecipitate is the insoluble material that comes out of solution after frozen plasma is thawed. It is rich in plasma proteins, especially fibrinogen, and contains a concentrated source of clotting factors.

3.A- Surfactant is a lipoprotein molecule that reduces the force of surface tension from water molecules on the lung tissue, thus reducing alveolar surface tension.
