- Exhibits are arranged in common areas to provide easy access for participants during registration, program breaks and networking sessions.
- Exhibit areas will open Tues. and Wed., Oct. 14 and 15, 2025. Specific exhibit hours and set-up information will be forwarded to exhibitors.

An Exhibit Contract is attached for sponsor and exhibitors. Payment must be received prior to August 15, 2025 to confirm your reservation. Checks should be made payable to FANNP. (Federal tax ID #65-0213738)

Cancellations: Exhibitor Cancellations received prior to 8/15/2025 will be issued a full refund less a \$50.00 administration fee. Cancellations received 8/15/2025 - 9/15/2025 a refund of half of the registration fee will be issued. After 9/15/2025 no refunds will be issued. In the event FANNP would need to cancel the conference for weather or an event beyond our control we will notify you as soon as we are aware. There will be a choice of a full refund less administrative fees or an option to apply the paid registration fees for the next year's conference.

- ✓ Confirmation of exhibit space will be mailed within 2 to 3 weeks of receipt of contract and payment.
- ✓ Conference and exhibit hours: Open Oct. 14 and 15 set up Oct. 13 after 2 pm.
